## Ohio County, WV Poll Worker Registration/Application Form



To serve as a poll worker, you must

- Be registered to vote in your county. Check your registration, update your registration, or register to vote for the first time any time at <u>GoVoteWV.com</u>;
- Be able to read and write the English language.
- Attend training; and
- Be available to work all of Election Day.

You may not serve as a poll worker if:

- You are a candidate on the ballot or an official write-in candidate in the election.
- · You are the parent, child, sibling, or spouse of a candidate on the ballot or an official write-in candidate.
- You are prohibited from serving as an election official due to any other laws or disqualifications.

The Ohio County Commission recognizes the importance of our informed and dedicated Election Workers. The rates for Elections Workers are as follows:

Poll Clerk	Checks in voters at entrance table	\$270
Election Commissioner	Assists voters to machines/ballot box	\$270
Training Class	Training from Election Office Staff	\$30
Supply Person	Drives results to City-County Building	\$30
Escort	Accompanies Supply person to City-County Building	\$15
Stays with machines	Waits at precinct for equipment to be picked up	\$15

Additional tasks such as supply person, escort and stay with machines will be assigned to poll workers by the Election Coordinator
